Terms and Conditions:

- Vendors must register with the Vendor Leader before setting up.
- Limited number of vendor spaces available
- Set up starting at 8:30 am / take down starting at 4:00pm at 293 Ditto Landing Rd, Huntsville, AL 35803 – near the dry boat storage.
- All products exhibited should be in good taste, family friendly and ready for safe use by the purchaser.
- Vendors must be present for the full duration of the fundraiser.
- Vendors must furnish their own displays, tables, chairs and your own source of power, if needed.
- Each exhibitor will stay within his allotted space(s).
- When using stains, paints, etc., a protective covering must be placed on the ground, under and around work.
- All exhibits must be in place by 9:45 a.m. before the event starts and completely removed by 4:45pm.
- Unprofessional conduct and/or failure to comply with fundraiser rules are just cause for removal from the park.
- Exhibitors: If you must bring children, they must be supervised at all times.

General Information:

- There is NO admission charge to the general public.
- Vendors requesting adjoining spaces are required to mail individual applications together.
- Applications must be complete and include payment of appropriate fees.
- Not all applicants will be accepted due to limited space or too much repetition of product.
- No use of alcoholic beverages on their premises.

Fees:

- Non refundable
- 10x10 is the largest space. If you need a larger space you will need to rent two spaces (limited number available).
- A \$30 handling fee will be charged for checks with insufficient funds.
- Exhibitors will be charged a \$20 cancellation fee for all cancellations. Exhibitors may expect NO refunds on cancellations.
- A \$30 cleaning fee will be charged if a booth space is left in a disorderly manner.
